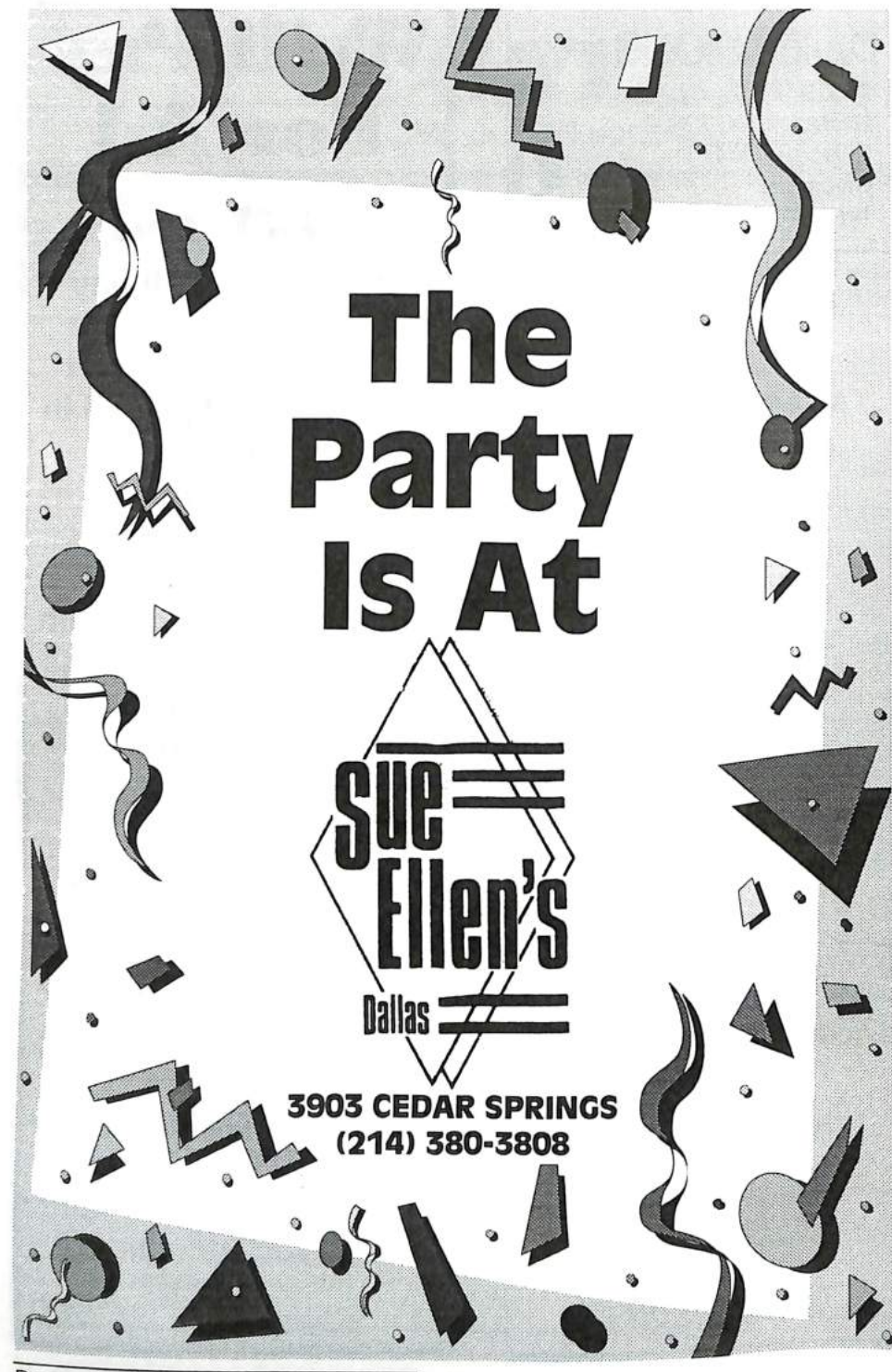

COORS GRANTS BENEFITS TO

SAME-SEX PARTNERS

COLORADO - The Adolf Coors Brewing company extended employee benefits to same-sex partners on May 11. The company has been the target of gay rights advocates since the seventies and is still actively boycotted by many members and groups within the community.

The most recent criticisms do not revolve around the Brewing Company but around the Adolf Coors Foundation, which is funded by the Coors family. The Foundation has openly supported right wing organizations such as the John Birch Society, the Free Congress Foundation and the Heritage Foundation, according to the *Colorado Daily*.

Organizations calling for the boycott believe that the Foundation is a mechanism for the family to funnel money to anti-gay causes while claiming that Coors, the company, is a gay affirmative organization.

It is unknown at this time whether the organizations involved will call for an end to the boycott. However, the National Gay and Lesbian Task Force continues to refuse donations from Coors.

RIGHT WING WORKING HARD

The American Family Association (AFA), Donald Wildmon's right-wing organization dedicated to media monitoring, claims an "active involvement of one million plus supporters." Wildmon describes his organization as America's #1 pro family organization fighting for wholesome, family-oriented TV." His well-funded efforts continually demonize gay men and lesbians while dispensing misinformation about our lives.

Wildmon's newest campaign calls for a boycott of Unilever products which include Calvin Klein cosmetics, Close-up toothpaste, Q-tip swabs, Vaseline products, Lipton tea and Dove, Lifebuoy and Lever 2000 brands of soap. According to Wildmon, Unilever is "a leading sponsor of programs promoting homosexuality."

The campaign involves a "Nationwide Television Values Survey," mailed to his members. The "results" of the "survey" will be shared with major TV advertisers. The highly biased survey materials, (which doubles as an AFA fundraising letter) state: "Our children are crying for network TV to teach them values, Hollywood and network TV give your children...OVER 15,000 SEXUAL ACTS AND INNUENDO IN A GIVEN YEAR!"

"The single best way to change what's on TV," Wildmon writes, "is to

CONVINCE CORPORATE AMERICA TO STOP SPONSORING TV SHOWS which TEACH our children to be...SEXUALLY ACTIVE...ANTI-GOD and ANTI-FAMILY."

With his "values survey," Wildmon has shipped out thousands of "boycott cards" that list Unilever's many products, instructing his members to "Send a message by leaving these products on the shelf." They have also been given pre-printed complaint postcards, addressed to Unilever.

It's important for Unilever to hear from consumers who support the fair, accurate and diverse representation of lesbian and gay lives. In addition, the AFA is calling for a boycott of all products manufactured by Bristol-Myers Squibb because the company has advertised its Clairol Men's Choice hair products in The Advocate. LESBIAN/GAY POLICE CONFERENCE TO BE HELD IN PALM SPRINGS

LOS ANGELES - The Golden State Peace Officers Association, California's Lesbian & Gay Police organization, and the Los Angeles Police Department, proudly announce their co-sponsorship of the Second International Conference of Gay & Lesbian Criminal Justice Professionals. This series of educational seminars represents the first time any police department in the United States has fully cosponsored a professional event dedicated to the examination of issues concerning gays and lesbians in law enforcement.

The conference is expected to draw as many as 500 participants from around the world, with representatives expected from London, Copenhagen, Paris and Australia. It will be held on Friday, September 8, 1995 in Palm Springs with additional educational and networking gatherings scheduled throughout the Los Angeles area from September 5 through September 10.

This second professional gathering will address a variety of topics including decreasing discrimination in the workplace, equal opportunity issues, coming-out on the job, AIDS & HIV, and concerns of women in law enforcement.

The conference is designed for lesbian and gay police officers, deputy sheriffs, firefighters, parole and probation officers, prosecutors, as well as all other interested law enforcement managers and executives who are dedicated to

creating a positive working environment for an increasingly diverse work force. The first such conference was held in New York City in June of 1994, in conjunction with the Stonewall '25 celebration and proved to be an effective forum for lesbian and gay criminal justice professionals to exchange ideas, network with one another, and to discuss relevant issues in law enforcement.

Ms. Elizabeth Birch, Director of the Human Rights Campaign Fund, and Deputy Superintendent William

Johnston of the Boston Police Department will be featured speakers at the event. Other panel speakers include Police Commissioner Art Mattox and Assistant Chief Ronald Banks of the Los Angeles Police Department, Chief Leroy Baca of the Los Angeles County Sheriff's Department and retired Chief of Police Penny Harrington of the Portland Police Bureau.

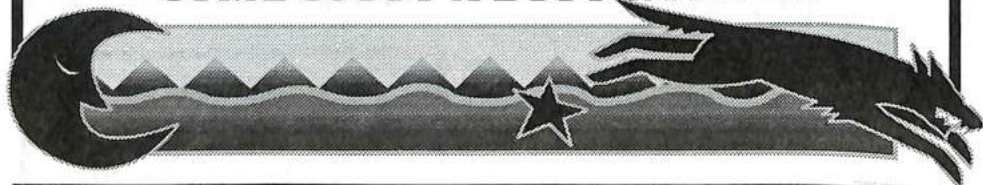

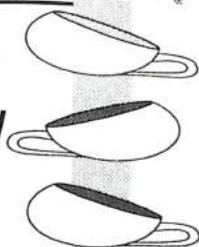

SEXUAL HARASSMENT

What it is and how to fight it

Ever since Anita Hill came forward with accusations against Supreme Court nominee, Clarence Thomas, the term "sexual harassment" has become a household word. There have been TV specials, talk shows and even a movie made on the subject (with a woman as the harasser). However, there is still a whole lot of confusion out there about what sexual harassment is and who the perpetrators are. Of the three cases below, pick the the one (or ones) you think constitute sexual harassment.

Case 1: John Freshman presses against you ever chance he gets; any excuse will do, asking a question, reviewing a report... When he comes in the office he presses up as close as physically possible and then never seems to notice that it makes you uncomfortable. This guy is always in your intimate space!

Case 2: Fred Slez is the company trash mouth. He repeats every dirty,

ethnic and sexist joke he hears to the whole office. It is Monday morning, he is loaded with a new list and here he comes, "Do you know how many lesbians it takes to change a light bulb?..."

Case 3: "Yes, Jamie your work is really appreciated, but if you ever expect to get a raise or promotion around here, Honey, you better lighten up and start socializing... Know what I mean?..."

Case 4: Bob, the single guy in the next office asks you to go out to dinner and a movie. You politely tell him that you don't want to go out with him. Afterwards he is still friendly, but doesn't ask again.

Once upon a time, a person who was being sexually harassed at work had to either put up with it or leave the job, hoping that a new job would offer a more professional work environment. By 1980 things began to change, you had the option of filing a complaint, but a final resolution of the case could take years. Then, in 1986, the Supreme Court handed down a decision that said the employer was responsible for a harassment free environment and further responsible for the *prevention* of sexual harassment.

Today most major companies have a sexual harassment policy.

But what is sexual harassment???

There are no clear cut guidelines for determining what is and what isn't sexual harassment. Sexual harassment is what ever makes you feel uncomfortable.

Legally, there are two categories of sexual harassment—the first is defined

as an intimidating or hostile work environment. This can be a result of teasing, comments, the presence of suggestive posters, or sexual jokes. The second is unwelcome physical or verbal behavior of a sexual nature. This behavior may be an implied or an outright condition of your employment, wages, or advancement.

What to do.... if you are being sexually harassed?

1. Confront the "harasser"! Tell him that his behavior is offensive and that if it continues you will report it to his supervisor. (Document the date you confront him. This can be a simple note on your calendar at home.)

if he doesn't stop?

2. Warn him again. This time both verbally and in writing that if his behavior continues you will notify his supervisor or manager and the personnel department. (Keep a copy of the letter and note the date you sent it on your calendar)

All documentation should include the date, time, specific behavior, and details involved. Be sure to note any witnesses present. Always keep copies of all your records.

If the behavior persists?

3. Use the company complaint procedure. If there isn't a formal complaint procedure, go to the next ranking supervisor in the department. Remind the supervisor, manager, or employer that it is the company's responsibility to correct the situation.

If you still can't get the situation corrected?

4. Further contacts include your States' Labor Department and the EEOC [Equal Employment Opportunity Commission] 1-800-USA-EEOC. They will direct you to a regional office.

It is essential to follow these guidelines and DOCUMENT your actions. You should always confront the person verbally first. That gives them the benefit of a doubt—there is always a possibility that they really do not realize their behavior is offensive to you. Further, a sexual harassment charge can ruin a career and won't leave either party untouched. While the harasser may suffer the loss of his job, you may also gain a reputation as a troublemaker and possibly ruin your chances for promotion within the company. Trying to talk it out in private can help resolve the problem with less career and emotional damage for both of you.

At the beginning of this article we asked you to choose which case(s) represented sexual harassment. All of them except case number four constitute harassment.

If it makes you feel uncomfortable, embarrassed or pressured - it is harassment. Keep in mind that even though the examples in this article refer to a male harasser/female harassee, this is not always the case. Harassment can occur at all levels of employment and can

come from members of either sex. It is very unprofessional for a supervisor, manager, or anyone of authority to solicit sex for favors. Under the law you are entitled to a comfortable, harassment-free work environment.

As for case four — if someone in your office asks you for a date, you have every right to accept or turn them down depending on your own feelings and the policies of your company (some companies don't allow employees to date one another). You always have options as a consenting adult. Having said that, you should also know that if you had turned Bob down and he continued to ask you out or started leaving flowers on your desk every day even after you asked him to stop, case four could easily turn into sexual harassment.

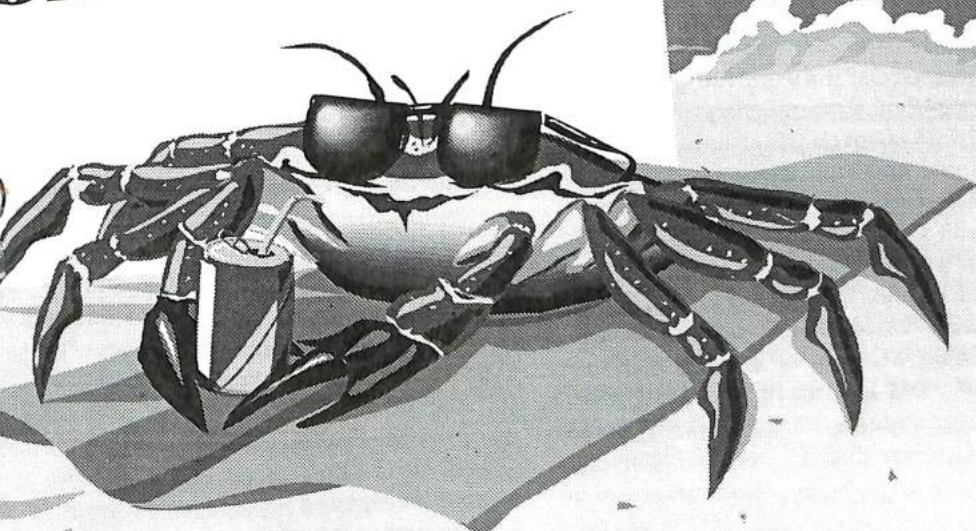

WHAT A WORLD, WHAT A WORLD THEATER OF THE MIND

Don't Look now. Another "lesbian movie" has been released.

The Incredibly True Adventures of 2 Girls in Love is being heralded by critics as a rarity — a "lesbian movie" with crossover appeal. It's the story of two mismatched lovers from the opposite sides of the track. Passion triumphs when two high school sweethearts defy the odds and choose to love each other, regardless of the obstacles thrown in romance's path. It's kind of like a funny Romeo and Juliet without the death, the period costumes, or the penis.

It seems so strange to enter a movie theater and enjoy a film about "us" that isn't tragic, or preachy, or at least pretentious. Wonderfully strange. Things have changed so much. Whatever happened to those movies with "adult overtones" that merely hinted at the "different-ness" of the protagonists? In a world full of changing social mores, the one constant we could always count on was that these movies would end with everyone coming to their senses and riding off into the sunset with a companion of the opposite sex. Or we could bet n some accident to tear the ill-fated lovers asunder. Suicide, at least. Good grief, is nothing sacred? Could it be that as acceptance of gay men and lesbians is becoming more mainstreamed in the real world (whatever that is), our characters are also finally, being mainstreamed onto the silver screen?

Maybe these really are the Gay 90's. Never before in the history of film has the industry been so inundated with films dealing either specifically with gay and lesbian themes, or at least including a strong gay/lesbian presence. Yesterday they had *Going My Way*. Today we have *Priest*. I like it — how about you?

One of the best things about all this gay cinema is that it sheds a welcome light on our culture, our *modus operandi*, our essence, that might otherwise be overlooked. "Do you still think we'll still know each other when we're 30?" is a poignant question the 2 Girls in Love ask each other. Research and conversation has indicated, at least to me and my contemporaries, that not only do most lesbians still know their first lover, they continue to play a major role in each other's lives. What doesn't kill us, makes us stronger? In fact, bringing a new paramour home to meet "the family" now often means introducing her to your ex-lover, your ex-lover's current wife, her current wife's ex, and her current wife's ex's gay cousin from out of town who we think is probably gay but no one is completely sure. Welcome to Lesbianville — we hope you enjoy your stay here.

It's become a welcome trend for filmmakers to focus specifically on various lesbian rites — and wrongs — of passage. *Bar Girls* gave us an accurate

backstage view of the theater where most lesbians give their first — and best — public performances. *Desert Hearts* gave us a tasteful yet provocative lesson that love, especially when you find it in Reno, is always a gamble. *Claire of the Moon* gave us a rash. *2 Girls* gives us a nostalgic tweak recalling the unspeakable excitement and incomparable buzz that accompanies first love — that constant ache in your stomach that has never before or since hurt so very, very good.

It's encouraging that lesbians (and gay men, for that matter), can now go to a neighborhood theater, other than the kind that only accepts quarters, and enjoy a positive film experience. Prior to this new cinematic enlightenment, a gay person's identifying and internalizing a film experience was limited to fantasy.

So fantasize I did. The following is a list of films that I hope to be able to experience before my buttered corn-popping days are done.

What's So Funny Girl? Instead of joining hopeless gambling addict Nicky Arnstein on that European bound luxury liner, Fanny Brice remains in New York at the curiously-insistent urging of co-chorus gypsy Ann Francis. They spend hiatus from *The Ziegfeld Follies* writing their own terse, two-woman comedy show which becomes the vaudevillian precursor to *The Kathy and Mo Show*.

Parent Trap: The Rest of the Story Hayley Mills plays grown up twins who discover they're not really twins at all, but completely unrelated. In an ultimate act of narcissism, they fall in love with each other and marry. Mayhem ensues as they become famous as the only

bickering couple in film history who, after telling each other to go f _ _ _ themselves, actually can.

Mommy, You're the Dearest Devoted adopted daughter discovers that her mother, an old former motion picture queen, is really just an old queen.

Orlando, Part Deux Quentin Crisp stars as the Mayor of a steamy Florida tourist mecca which receives its water supply from Ponce de Leon Natural Springs, giving all its citizens eternal life and unlimited potential for sequels.

The Whining Game Audiences are shocked at the surprise ending when the film's heroine, a cabaret singer and model, is revealed to actually be a woman. Kinky.

When Harry Forgot Sally in Paris A man and a woman, supposedly in love, re-evaluate their relationship when he joins the chorus line in the Follies Bergere.

Other cuts on the CD include "Secret Love," "Over the Rainbow," "Somewhere," "When I Fall In Love," and "Love Don't Need a Reason."

It is truly amazing to listen to this CD and realize that all those beautiful voices belong to the gay and gay friendly communities of Dallas, Texas. There must be something in the water in Dallas to produce such a wonderful array of singers.

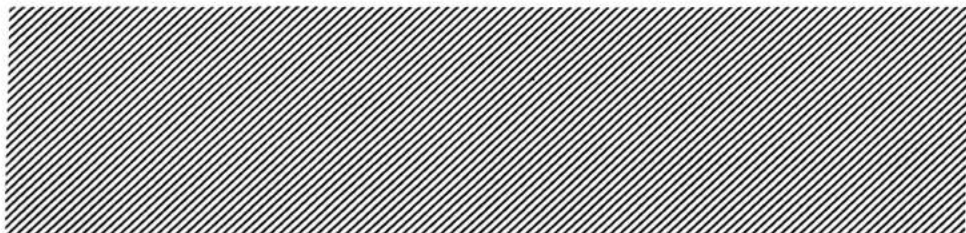
