FAGS and LESBIANS are RUNNING

Their massive bodies trembling with passion, their eyes ablaze with lust, the fourteen swarthy convicts pushed and jostled each other and struggled for position outside the locked cell door.

Inside the cell, the target of their insane passion curled up fearfully on the corner of a cot and stared at them through the bars.

"Coming through!" shouted a voice at the rear of the mob. "Coming through with the keys!"

The cons yielded just enough for him to worm his way to the cell door. Meanwhile, two burly six-

footers poked their heads through the bars and grinned lasciviously at their young, redheaded and delicately pretty potential victim.

"Get ready, darlin'," the larger of the two cooed with mock sweetness. "We're coming to take your little..."

The redhead, trembling visibly, watched with an expression of horror as they lecherously wrung their hands and noisily smacked their lips.

Now the key turned in the lock and the door banged open. The convict at the head of the pack charged into the cell. He pinned the redhead's shoulders to the cot while two others tore off every stitch of clothing.

Then, one by one, the fourteen cons savagely punched, pummeled and finally raped their trembling victim. The more resistance they encountered, the better they liked it. They didn't let up until the redhead lay limp, semi-conscious and completely obedient to their wishes.

Incredible?

Sounds like something straight from the pages of one of those sex-and-violence paperback novels?

Well, hard to believe as it may be, the savage orgy is one hundred percent true.

It took place not in the mind of some demented dime-store novelist, but at Jackson Prison in Mississippi.

The time was not 1900 or even 1950, but just a short while ago.

And the delicately pretty, redheaded rape victim was not a girl, but a *boy*—a young accountant who had been imprisoned for forgery and who soon thereafter became so sought after by wolf packs of queer cons that prison officials had to keep him "in permanent segregation" for his own physical safety.

Furthermore, the mass rape was only one of many homosexual assaults which took place at Jackson Prison at the height of the sensational riots which made newspaper headlines.

While the fourteen ferocious rapists were venting their lust on the hapless redhead, other cons prowled

- "Butches" who work hard at making their "femmes" jailhouse sharp . . .
- "Punks" and "studs" competing for the favors of an aging "queen" . . .
- Conscienceless attendants stocking prisoners' libidos with goof-balls, narcotics and barbiturates . . . This is the sex-circus today in some of our penitentiaries and mental institutions!

the cell blocks and prison recreation areas brutally assaulting scores of other youngsters.

Prison officials stood by helplessly as their penitentiary was turned into an immense arena of debauchery, depravity and homosexual mayhem.

And Jackson is by no means the only prison where homosexual assaults and crimes have been entered upon the record. The truth of the matter—well-documented, though long suppressed by many corrections officials—is that fags and lesbians today are actually running wild in American prisons. There is little which authorities can do to stop them, and some don't even try!

At New York City's Women's House of Detention, for example, three college girls arrested in a pacifist sit-in demonstration complained that they suffered brutalities and humiliation at the hands of homosexual prisoners who went "unrestrained by prison authorities."

Questioned a short time later by newspaper reporters, House of Detention Superintendent Mrs. Mary Lindsay said:

"Do we have homosexuality? So, who doesn't?"

Meanwhile, at Crown Point, Indiana, three prisoners filed statements with sheriff's investigators alleging sexual intimacies at Lake County jail.

Prosecutor Henry S. Kowalczyk, announcing plans to assemble a six-member grand jury to look further into the scandal, said:

"All told, a dozen or more persons may be involved in this mess."

And the problem of sex in public institutions involves not only regular *penal* institutions but also juvenile "detention" centers and state mental hospitals.

For example, New Jersey State Assemblyman Joseph J. Maraziti, heading an inquiry into irregularities at Greystone Park State Hospital, uncovered evidence that five attendants assigned to a male ward had rigged up a passageway to a female ward, where they gained "carnal knowledge" of eight patients.

Moreover, according to Maraziti's official report, there was "reasonable basis for strong suspicion that two male patients were (also) involved."

And, while the Greystone investigation was going on, the assemblyman received a report from the State Commission on Institutions disclosing similar irregularities at Trenton State Hospital.

Meanwhile, authorities in La Porte, Indiana, found themselves perched on the brink of a huge homosexual scandal involving Michigan City State Prison.

Homosexual convicts, it seems, not only were cavorting wildly with each other, but also were "turning on" before their orgies with "goof balls" purchased through the office of the prison dentist!

HOMOSEXUAL SCANDAL

The dentist, Dr. Arnold R. Grindle, was fined \$100 and given a suspended 90-day jail term by City Judge Conrad Kominarek after he pleaded guilty to purchasing 2,000 tablets of amphetamine sulphate and turning them over to two "trustees" who worked in his office.

The trustees sold the pills to other prisoners, who used them to "turn on" before "gay" sessions—or some-

times for just solitary flights to dreamland as well!

What's behind this current rash of sexual hanky-panky behind bars? How long has it been going on? Is there any way out?

This much is certain: While there always was a sexual problem in prisons, the situation today is worse than ever.

In 1948, for example, Dr. Alfred C. Kinsey believed that the problem of prison sex was greatly exaggerated.

Wrote Kinsey at that time:

"While it is erroneously believed that males in a prison find an abundant release through the homosexual, and while it is in actuality a fact that a high percentage of them do become involved in such activity after they have been in a penal institution for some length of time, neither the homosexual nor autoeroticism ever provides any frequent outlet for more than a small portion of a prison population..."

However, in the sixteen years which have passed since then, things have changed—and most authorities today feel that the problem is not in the least bit exaggerated.

In 1964 Philadelphia psycholo-

gist John S. Yankowski, author of *The Yankowski Report on Premarital Sex*, wrote:

"American prisons have become hotbeds of homosexuality and perversion where young inmates are often coerced into performing unnatural acts which may permanently mark their lives. If a man is sentenced to an American prison for three years, chances are seven in ten that he will engage in at least one act of overt homosexual behavior before he gets out—and it is quite likely that homosexual habits begun in prison will be continued after the prisoner has returned to society."

Support is given to these statements by sociologists, penologists and prisoners themselves. The reports of prisoners are often especially revealing.

For example, Virginia McManus, the ex-school teacher who made headlines a decade ago as one of the girls in the famous Mickey Jelke vice case, disclosed after her release from the Women's House of Detention in New York that some 95 percent of the prisoners she met there mingled sexually.

"About 50 percent of the inmates," she declared, "are (confirmed) lesbians who desire no male sexual partners . . . For some of them, jail is the best place. They couldn't enjoy themselves so much outside."

"For the few straight girls who don't want to bother, nobody bothers them. But practically everybody does it once they're in jail, even if they're not lesbians at the time of their arrest."

"Why I met married women who got thrown in for 30 days, had a ball with the other girls, then went out and home to their husbands."

Questioned about Virginia's charges, New York Commissioner of Corrections Anna Kross had no choice but to deplore—and admit to—the situation.

"What can I say?" she told reporters. "There are more than 600 women in a building designed to house about 300 . . . Can we put a guard in front of each cell?"

According to Virginia McManus, that's precisely what would have to be done if the problem was to be alleviated.

"Some of the women," she points out, "have so-called husbands. They date steady. The masculine women are very much in demand. You should see the wooing that goes on. One girl, a real masculine type, had her own stable of six women . . ."

BUTCHES AND FEMMES

"There's television and movies once a week—on Saturdays. The girls make dates with each other to go to the movies, or to be with each other after dinner and before lights out. That's when they lock the doors of the cells—with two girls in each cell."

Prison lesbian society, she goes on, is divided into two groups—the "butches," who play the male role in the sexual act, and the "femmes," who play the female role.

"The butches—sometimes we call them 'jailhouse daddies'—like to have their girls 'jailhouse sharp.' Having a uniform so starched that it

will stand up by itself is really being 'jailhouse sharp.'"

The situation is somewhat similar—but more complex—in male prisons. Here there are two types of aggressive homosexuals: "queens" and "wolves."

The queen is the stereotype "swish" or "pansy", identifiable from a mile away by his traditionally hip-swinging gait, limp-wristed pose and soprano vocal inflection. He is usually exclusively homosexual—i.e., completely uninterested in women—even outside prison, and takes no greater delight than in "bustin' a cherry," which means seducing a young inmate who has never participated in homosexual acts.

While he plays the male role in "courting" the object of his affections—sometimes going as far as to bribe a potential bedmate with gifts of candy, cigarettes or other items hard to come by in prison—he plays the part of a girl in sexual acts.

Meanwhile, the "wolf" likewise plays the male role in courtship, but, unlike the queen, plays the male role in the sexual act also. This makes his pleasure-seeking considerably more difficult, and often leads to the coercion or even rape of an unwilling partner.

When a new inmate arrives at a prison, both the wolves and the queens compete for his favors. The younger he is and the better looking, the higher are the chances that he will be sought after.

If a newcomer resists the advances of a prison wolf, chances are that he'll suffer for his reluctance. There are many cases on record like the Jackson case, where younger prisoners were raped by wolves and/or brutally beaten. There are even cases where infuriated wolves, turned down by a boy they tried to seduce, actually murdered the resistant victim.

When a wolf takes physical vengeance on someone who has rejected him, he makes it clear to everyone the reason behind his attack. In most prisons the trademark of a vengeful wolf is a brick or a stone, wrapped in a sock; this home-made weapon, used to bludgeon the victim, is left alongside the body as a sign that the beating was administered after homosexual advances were spurned.

What effect does this atmosphere have on the normal, heterosexual young man thrown into prison for the first time?

If he gives in to the advances of a wolf, he becomes a "punk"—the term which convicts use to designate a passive homosexual who plays the female role physically and allows aggressive homosexuals to se-

duce him while not actively soliciting other persons himself.

If he gives in to a queen, he becomes a "stud"—a passive homosexual like the punk, except that he plays the male role physically during the sex act.

After a time, when age takes its toll on him and the wolves and queens no longer vie for his services, the passive homo usually turns aggressive. The punk may become a queen, the stud a wolf.

Thus the prison homosexual society perpetuates itself, constantly luring new members into the ranks to replace the old in the recruitment of still newer members.

What is life like among the prisoners' "gay society"?

Well, in the early evening before the lockups, a visitor might get the idea that he wandered into a high school hangout or a YMCA "mixer"—except that all the mixing is done by members of the same sex.

In a devastating burlesque of heterosexual romance, prison homosexuals make dates, exchange gifts of candy and cigarettes, write each other burning love letters and—believe it or not—actually undergo a ritual "marriage" in which convict lovers pledge eternal devotion.

THE "GAY SOCIETY"

Then there are the games.

In the desperation of their sex-mad loneliness some inmates organize themselves into "family groups" with a grandmother and grandfather (usually older cons), a father and mother, children, grandchildren and assorted uncles, aunts and cousins.

Intrigue and family quarrels are common, and members invariably try both to cut in on other members' dates or to fix up members with non-members they may have met around the prison yard.

In one women's institution the inmates reportedly work themselves into a heat of passion each evening with home-made variations of "straight" parlor games. Such children's favorites as "Buttony-Button" and "Twenty Questions" lend themselves to perverted parodies, and the classic "Hide and Seek" becomes "Hide the Button"—which is won when the con who was "it" finds the button on the body (usually in a very intimate area) of one of the other cons in the game.

Are prison officials generally aware of what's going on? There is every evidence that they are. But they look the other way—not necessarily because they condone homosexual behavior, but rather because it has been found that the

greater the official opposition to homosexuality, the more homosexual behavior actually takes place.

The explanation of this paradox is psychological. Prisoners indulge in homosexual behavior for two reasons: (a) sexual gratification, and (b) as a means of rebelling against authority.

While a firm stand against homosexuality by authorities might prevent homosexual behavior by prisoners who indulge solely for sexual gratification, the same stand would encourage a good many presently non-practitioners to practice homosexuality as a means of satisfying their desires to rebel.

Consequently, while virtually all administrators of prisons and mental hospitals take the public position that homosexuality is forbidden in their institutions, most of them in reality turn their backs to the situation—hoping that by so doing they can keep action at a minimum.

Must the situation remain the same? Is homosexuality a necessary evil of the penal system? Or is there a way out?

In most foreign countries, it has been found that a policy of permitting prisoners to have sexual intercourse with their wives (and, in some cases, with women who are not their wives) goes a long way toward alleviating the problem.

Pioneer in the field of conjugal intimacies for prisoners is Latin America, where most countries make some provision for the normal quenching of an inmate's sexual thirsts.

In Mexico, it is the prisoner's right—not merely his privilege—to be visited by his wife at least once a month and to have sexual intercourse with her. Furthermore, a sweetheart of long-standing may qualify as a "common law" wife.

Brazil prisons have small rooms set aside specifically for conjugal visits. So do those in Argentina, where any convict who behaves himself properly may be visited by his spouse in complete privacy.

Columbia goes a step further by permitting prisoners to leave their cells, under guard but wearing civilian clothes, and go to their own homes to have sex with their wives. If the prisoner's home is far from the penitentiary, he may meet his wife—or a girlfriend—at a rooming-house nearby.

Furthermore a Columbian bachelor who happens to be in prison can visit prostitutes; the only requirement is that the girls have been examined for venereal disease by prison doctors.

Similar policies prevail throughout Europe. In France, Italy and

Belgium, a prisoner who has been declared emotionally and mentally qualified may be given a furlough to visit his wife or sweetheart for an entire weekend. Sweden has home furloughs, too, and also provides for visits in special private cottages on the prison grounds. Russia likewise permits wives to visit prisoners and, in some institutions, allows the wife of a prisoner whose offense was minor to live right on the prison grounds with him.

Only one American institution has thus far made provisions to allow convicts similar liberties: Mississippi Penitentiary at Parchman, 150 miles north of the capital at Jackson. On Sundays—Parchman visiting days—inmates may meet with their families on prison grounds or in comfortable reception rooms, or adjourn with their wives to specially-designed cottages where they enjoy complete privacy.

Even the Parchman program, however, is incomplete in scope and discriminatorily administered: visiting privileges apply only to convicts who don't happen to be Negroes.

Is a program similar to that at Parchman—but uniformly and fairly administered—the solution to America's problem of prison homosexuality?

Some authorities think so. Others disagree. The answer, says the latter, is stricter discipline. When wardens lay down the law and let convicts know they mean business, the problem will disappear.

Whatever the case, there can be little doubt that the problem has not disappeared yet. Homosexuals and lesbians today are running wild in America's prisons and, until a genuine solution to the problem is found, they'll undoubtedly continue to do so.

This becomes an important thing to remember in view of the fact that a few years ago—and perhaps they are still doing it in some places—some fly-by-night organizations were reaping huge profits by bootlegging what they called Spanish Fly. Actually, they were using any blister beetles that happened along and selling the stuff to suckers right and left for boosting sex prowess.

These insects are called blister beetles because when you dry and powder them, the powder is capable of raising blisters on your skin. Only Spanish Fly has proven generally trustworthy, however, in raising one's sexual temperature.
